Springer-Verlag

Commencing 2008, www.scientificjournals.com have been transferred to Springer-Verlag Heidelberg. Therewith, typesetting and printing will be performed by Springer's production staff. Otherwise the manuscript process is the same as before. Submission system is the ESS (Electronic Submission System, see below). After having been accepted for publication, the manuscripts will be adjusted to the Springer layout by our Editorial Office (pre-layout). This version will be submitted to you, the authors, for a final check. Thereby we can avoid expensive and time-consuming changes in the page layout (page proof). Please note that the purpose of the proof is not to revise the paper but to correct mistakes that may have occurred during the setting (layout) process. Springer's production system is the Joint Work Flow (JWF) that processes 1800 journals. This means that every step takes longer than you are accustomed to as yet. Therefore, the less changes in the page proof occur, the sooner the paper can be published in OnlineFirst.

The most important change in the preparation of the manuscript concerns the literature citation. Please arrange the order of references alphabetically only.

Before Springer provides the page proof, you will receive an email request from Springer so as to indicate whether you wish to

- Order OpenChoice, i.e., make the published version of the article available with open access, against a fee of 2500 EUR / 3000 USD)
 - Order paper offprints of your article upon issue publication
 - Order printing of figures in color in the Journal (950 EUR per paper)
- and to
- Transfer the copyright of your article (if you do not order OpenChoice)

Not until you have answered the queries, the production process can start.

Dear Authors, as you have decided to publish your paper in this journal, you are requested to make yourself familiar with both the Guidelines and the relevant literature in **JSS** and the closely related **ESPR** to be integrated in your paper. Please submit via the ESS only papers to be peer-reviewed. Other types of articles (Editorials, Letters to the Editor, Book Reviews, Conference Reports) can be sent via email. The ESS access page describes the individual steps of submitting papers.

Manuscript Requirements (MS-Word for Windows)

To authors from non-English language countries:

To have the best possible pre-requisition for the review process, please ask a native speaker to check the quality of the English, before you submit the complete paper.

Language clearing by our language service prior to submission / publication requires a language charge of Euro 25.00 per hour plus VAT. Average value, depending on paper length and language quality: 1.0 to 3.5 hours.

The Seven Basic Rules

1. At the **head** of your manuscript, please record: Date of submission, number of text pages, figures, tables, equations
2. Include **page numbers** at the foot of the pages
3. Use block format
4. Do not make use of **automatic syllabifying**
5. **Quotation marks:** Use single quotation marks. Double quotation marks should only be used for real quotations
6. Do not make use of underlining words, of capitals and small capitals
7. Do not make use of active documents (templates, email and internet addresses)

Length of Articles

Verify that the manuscript does not exceed the length of **10 layout pages***, including tables and figures.

- Research Articles (full papers): up to **8 pages***
- Short Original Communications: up to **4 pages***
- Review Articles: up to **10 pages***
- Commentaries and Discussion Articles: up to **6 pages***

If more space is needed, please split the paper in two or more parts to be published in subsequent issues. In this case, provide a short **preamble** that covers all parts, in addition to the individual abstracts.

* The pages refer to the following page format that is equivalent to one layout page (see [sample paper in WORD](#)):

Page setting

Top margin: 3 cm; bottom margin: 3 cm; left margin: 2 cm; right margin: 2 cm

Type face:

Times New Roman (throughout the paper, excepting in figures)

- Title: 16 pt bold face; subtitle: 12 pt, bold face
- Author names (complete names): 10 pt, bold face
- Author addresses (complete, including e-mails): 8,5 pt
- Abstract/Keywords, Text (incl. subheadings in bold face): 10 pt
- Acknowledgement, reference list: 8,5 pt

Just follow the sample paper, and you cannot fail.

Abstract with Keywords

Please separate the abstract into the following sections (see [sample paper in WORD](#)):

- Background, Aim and Scope
- Materials and Methods (or, for review articles, Main Features)
- Results
- Discussion
- Conclusions
- Recommendations and Perspectives (or, for review articles, Perspectives)

Keywords: up to 15, in alphabetical order and separated by semicolons

Please organize the text according to the sections of the Abstract.

Literature

Order the references **alphabetically** only. Use the **international abbreviations** for journal titles.

Examples within the text:

Human health impact chains assessed with DALY include toxicity (Hofstetter 1998; Goedkoop et al. 1998; Crettaz et al. 2002; Pennington et al. 2002; Huijbregts et al. 2005; Meijer et al. 2005), ionizing radiation (Frischknecht et al. 2000) and road noise (Müller-Wenk 2004); as well as occupational health impacts in the US input-output (I/O) table (Hofstetter and Norris (2003).

Tables (to follow the text, see [sample paper](#)):

1. Please use the table function available with WORD. Do not use tab stops
2. Width: 8.4 cm or 17.4 cm
3. Fonts (typeface): **Times New Roman**. Type size: 8.5 pt (end size)
4. Do not use shadowing
5. Note that references to tables should be marked with lower-case letters (if needed, use in addition asterisks)
6. Use no double lines but lines of 0.5 pt strength above, below and within the table

Figures (to follow the text, see [sample paper](#)):

1. Format: TIF, PPT, EXCEL, bound in WORD; resolution: 300-600 dpi; line strength: 0.5 pt, width 8.4 or 17.4 cm
2. Lettering: **Arial**, 8.5 pt (end size)
3. Color reproduction requires a charge of EUR 950.00 per paper. Otherwise, colors must be altered to gray scales
4. Shadowing should only be used to accentuate important contents
